




Uzbekistan Demographic Trends Overview




POPULATION, MLN






INSURANCE PREMIUMS GROWTH RATE, %



- Ministry of Finance of the Republic of Uzbekistan is the member of International association of Insurance Supervisors (IAIS) 2009
- Tax remissions and benefits established

TAX REMISSIONS AND BENEFITS

- Insurance Premiums paid by individuals for Life and Property Insurance are exempted from income tax
- Insurance Premiums paid by entities for voluntary insurance are subtracted from tax base
- Dividend received from Insurance Companies stock are exempted from income tax
